The CoC, through its Performance Review Committee (PRC) conducted an objective review of the Portico project which resulted in the lowest score for all projects within the continuum (58 out of a possible 100). As part of its report on its project evaluation and scoring, along with its recommendation for ranking to the CoC membership, the PRC found that the coordinated entry project (the "CALL") was high performing and in need of additional funding. In light of this, scoring considerations and given an anticipated return of some funding by Portico, the PRC recommended a small reallocation of funding from Portico to the CALL project.
